**PLEASE EXERCISE YOUR RIGHT TO
VOTE ON NOVEMBER 2, 2010**

The following survey questions were submitted to each local candidate listed below:

1. Do you support legislation to clarify that human life begins at conception/fertilization? (when a human ovum is fertilized by a human sperm)
2. Do you support federal law that prohibits partial-birth abortion, the procedure that kills a living child during delivery?
3. Do you support taxpayer funding to pay for elective abortions?
4. Do you support the elective abortion of a child who is determined to have mental or physical disabilities?
5. Do you support "conscience clause legislation" that would give pharmacists the right to refuse filling prescriptions to be used as chemical abortions?
6. Do you support an informed consent law that requires that women considering abortion be given facts on the risks of abortion, information on alternatives to abortion, and information on fetal development, through in-person consultation performed at least 18 hours prior to an abortion?
7. Do you support laws that require the licensure and inspection of Indiana abortion clinics and requirements that abortion clinics meet basic health and safety standards?
8. Do you support enforcing penalties for abortion center "family planning" clinics, or any medical provider or other entity that does not report a child (under that age of 14) who evidences sexual activity?
9. Do you oppose any attempts to change the current Indiana standard of teaching abstinence—only education in public schools?
10. Are you opposed to using taxpayer funding to pay for elective abortions?
11. Do you support legislation requiring that women considering abortion be informed that an unborn child may feel pain during an abortion?
12. Do you support a ban on the use of stem cells from intentionally destroyed human embryos?
13. Do you support legislation to encourage stem cell research using non-destructive stem cells sources such as umbilical cord blood?
14. Do you support legislation in Indiana that bans assisted suicide?
15. Do you support ban on all efforts to clone human embryos?
16. Is a candidate for public office that supports abortion on demand, unacceptable to your personal viewpoint or beliefs?
17. Under what circumstances do you believe abortion should be legal (check all that apply) a) abortion should never be legal, unless it's to save the life of the mother; b) with proof of rape or incest; c) abortion should be legal in all cases or d) if the child is determined to have mental or physical disabilities
